

County Vehicle Accidents Handling Instructions
(For distribution to all Departments and retention in all vehicles.)

- 1) Notify police immediately - regardless of which party is at fault and regardless of location of incident.
- 2) Do not admit any wrongdoing. Do not advise that payments will be made.
- 3) If County employee is injured, file workers' compensation reports also. Forms are found on the County Intra-Net. (Go to closest Emergency Room for medical attention or if not, then medical treatment with Inspira Health Network, 1297 W. Landis Avenue in Vineland (856) 507-8548).
- 4) Supervisors must:
 - A. Call Hardenbergh Insurance, phone (609) 267-1453 or e-mail peclaims@hig.net.
 - B. Have County Incident Report Form completed and forwarded per routing instructions as soon as possible.
 - C. Obtain Police Report (do not wait for this report to submit County Incident Form- send other information when available).
 - D. Obtain and supply color photographs of damage to all vehicles involved in the accident.
 - E. List name of person in your department to contact regarding the accident.
 - F. If County vehicle is **not drivable**, then call the appropriate towing company listed below. **Please advise that the vehicle is to be towed to Bellmawr Collision Center, address below.**
Totaled vehicles can be stored in the County Public Works yard at 800 E. Commerce Street, Bridgeton.
 - G. If County vehicle is damaged but **drivable** - obtain a repair estimate from the body shop listed below.
- 5) Only if this applies, for CDL holders under D.O.T. Federal regulations, please follow the procedures for post-accident testing under the County Policy #4.05 for Safety-Sensitive Employees.
- 6) Department Heads must confer with the **County Administrator** to obtain authorization for repair of vehicle.
